

## How to register as a member of a Partnership – New PfS members

- Step 1: Access the [PfS Application Form](#).

If you are unsure whether your organisation is an existing member of the Pact, please follow [this link](#) to search for your organisation amongst existing members.

- Step 2: Answer the question “**Would you like to?**” with “Sign the Pact for Skills charter and make a specific commitment for your organisation”.

### Would you like to:

- Sign the Pact for Skills charter and make a specific commitment for your organisation
- Register a new partnership under the Pact as the coordinator
- Subscribe to the Pact newsletter and to receive information on the Pact activities (*please note that members of the Pact and members of existing large scale and regional partnerships are automatically registered to the newsletter and other communication activities*)
- Learn how to modify an existing application and/or change your communication preferences
- Input a contact relevant to the Pact (limited to the Pact for Skills Support Services Team)

- Step 3: Answer the question “**Is your organisation already a member of a**” with Large-scale Skills Partnership (LSP).

- Step 6: Review and add your commitments

We encourage all Partnership members to endorse the commitments of their Partnership. To do so, please select the option “Endorse the commitments of the skills partnership I’m a member of” in answer to “**Do you want to**”.

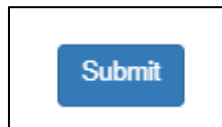
Please note that if you would also like to make individual commitments specific to your organisation, you can continue to do so by selecting the option “Yes” to the question, “**In addition to endorsing the**

- Step 7: Submit the application form by pressing “Submit” at the end of the application form.



Once your application form is submitted, you will see the '**Contribution ID**' of your application displayed. Please make sure to save this code, as this will allow you to access and edit your application in the future (e.g., change of contact details, update commitments, etc.).

- Step 8: Check your inbox for a confirmation email from the Support Services

After submitting your application, the PfS Support Services ([PactforSkillsMembers@ecorys.com](mailto:PactforSkillsMembers@ecorys.com)) will review your application and send you a confirmation email. This email will include the status of your application, and you may be asked to review elements of your application. With the welcome email, you will be a registered member of your partnership and of the Pact for Skills!
